To the Qualified Electors of the City of Rockwood:

Please take notice that a General Election will be held on Tuesday, November 4, 2014.

The last day on which persons may register with the appropriate City Clerk's Office, to be eligible to vote at the aforesaid election, is **Monday, October 6, 2014**. If you currently are not registered to vote or have changed your address in the above stated city in which you live, you may do so in the following manner:

In Person:

The City Clerk's Office located at 32409 Fort Road open between the hours of 8:00 AM and 4:30 PM.

At any Secretary of State Branch offices located throughout the state during normal business hours.

At the specified agency for clients receiving services through the Family Independence Agency, the Department of Community Health, Michigan Jobs Commission and some offices of the Commission for the Blind.

At the military recruitment offices for persons enlisting in the armed forces.

By Mail:

By obtaining and completing a Mail-In Voter Registration Application and forwarding to the election official as directed on the application by the close of registration deadline.
