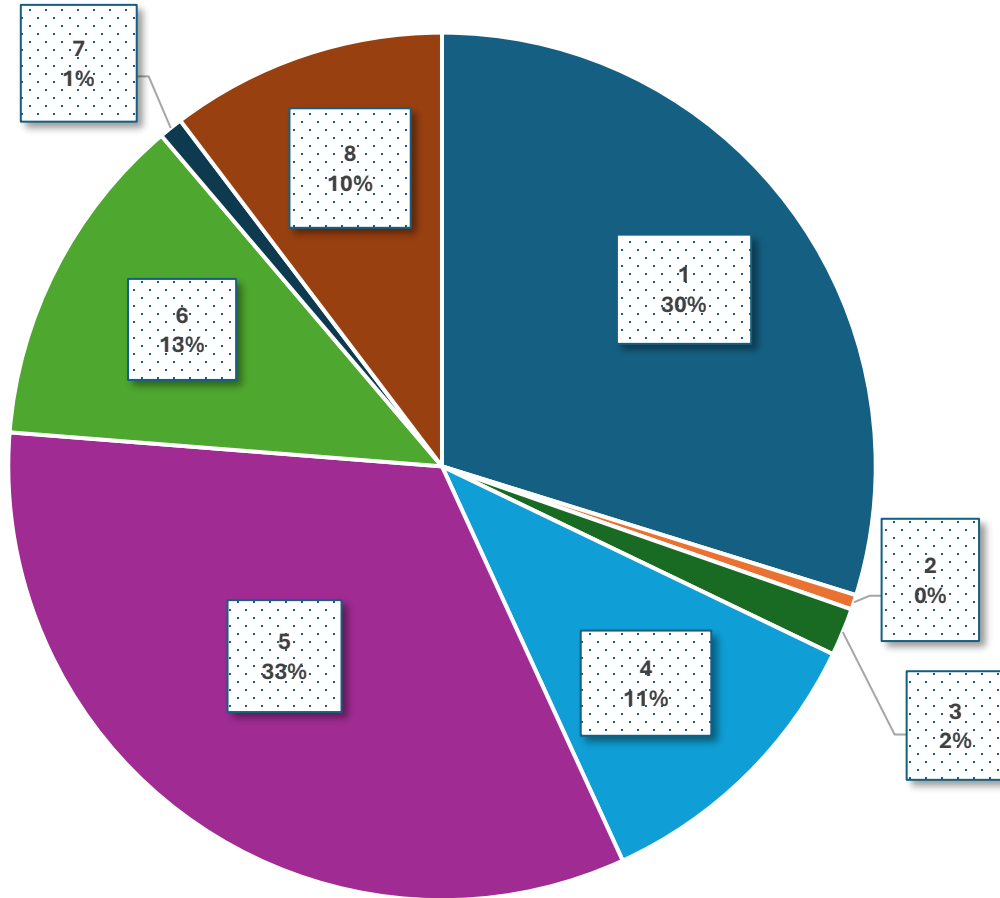


## Summer Tax Millage Allocation 2023

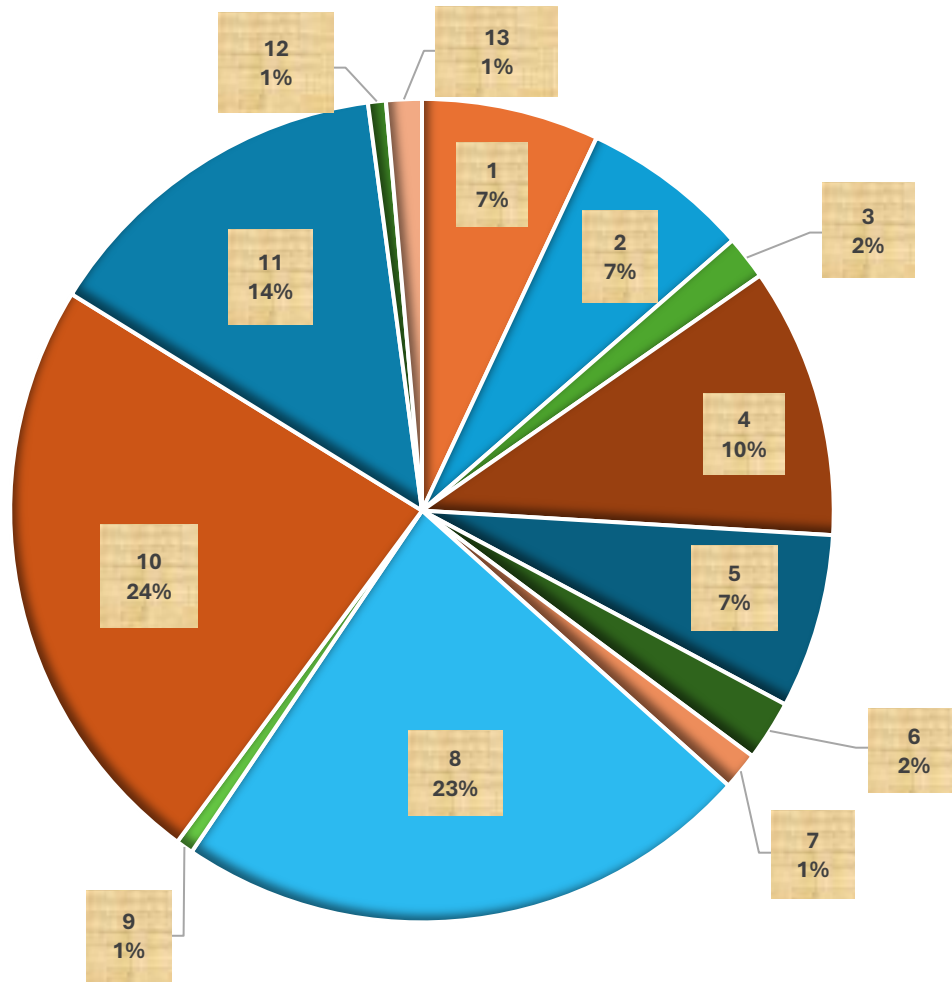


### Summer Tax 2023

#### Millage Allocations-distribution of funds

1. <b>City of Rockwood Common Fund</b> --used to pay the bills	<b>30</b> %
2. <b>Waste Water Treatment Plant (WWTP)</b> --used to pay for maintenance [half percent=0.005]	<b>0</b> %
3. <b>Roads</b> --used to pay for our local street repairs and upgrades	<b>2</b> %
4. <b>State Education Fund</b> --used to assist MI colleges with operating expenses	<b>11</b> %
5. <b>School Operating Fund</b> --used to assist educating our children in the Gibraltar School District	<b>33</b> %
6. <b>School Debt Fund</b> --used to cover debt for our Gibraltar School District	<b>13</b> %
7. <b>School Sinking Fund</b> --used for capital upgrades and emergency repairs for the School District	<b>1</b> %
8. <b>County Operating Fund</b> --used to pay operating expenses of Wayne County like all municipalities	<b>10</b> %
<b>Total</b>	<b><u>100</u></b> %

#### Millage Allocations-distribution of funds

1. <b>Wayne County</b> --used to pay for services to county residents	7 %
2. <b>Wayne County Jail</b> --used to construct and maintain the building housing criminals	7 %
3. <b>Wayne County Parks</b> --used to maintain and provide recreation equipment for all citizens	2 %
4. <b>Waste Water Treatment Plant (WWTP) Debt</b> --bond payments to rebuild the plant	10 %
5. <b>Roads</b> --used to pay for our local street repairs and upgrades	7 %
6. <b>Public Act 33--Fire Ambulance</b> --used to pay for updated ambulance	2 %
7. <b>Huron-Clinton Metroparks Authority (HCMA)</b> --used to maintain recreation facilities	1 %
8. <b>Wayne County Community College (WCCC)</b> --used to pay bills and provide adult education	23 %
9. <b>RESA* Operating Fund</b> --used to pay bills and provide educational opportunities for children	1 %
10. <b>RESA* Special Education Fund</b> --used to provide opportunities for children with disabilities	24 %
11. <b>RESA* Enhancement Fund</b> —used to supplement	14 %
12. <b>Zoo Authority</b> --funds used to pay bills for the Detroit Zoo in caring for animals	1 %
13. <b>Detroit Institute of Arts</b> --funds used to pay bills to maintain the Museum and exhibits	1 %
<b>Total</b>	<b><u>100 %</u></b>
