APPLICATION PROCEDURES FOR SHEDS

1. Complete application.
2. Plot plan must accompany application for proposed shed work with specifications. Please fill in all dimensions of the project you are planning, including all accessory buildings currently on lot. Sketch project on plot plan. Detailed plans must be filed with application.
3. Must comply with zoning ordinance.
4. Please provide copies of builder's license/contractor license and insurance.
5. Submit annual contractor registration form. Starts over yearly on April 1st.
6. Submit for plan review and approval.
7. Requires placement and final inspections.

Placement:

Sheds must be 10ft. from the main house and if the garage is attached, 10ft. away 2ft. from side and/or rear lot lines and in case of easements, either on the side or rear, 1ft. off any easement.

Foundation:

- Under 200 sq ft. **No foundation required.** If one is put in for use permit and inspections required.
- 201-400 sq ft. minimum size required is 12"x 24."
- Anything over 400 sq ft. minimum size required is 12"x 24."

A separate permit and inspections are required when any footing/cement is being placed.

Must comply with zoning ordinance ACCESSORY BUILDING.
