ORDINANCE NO. 506

AN ORDINANCE TO AMEND CHAPTER §212-11 OF THE ROCKWOOD CITY CODE TO AMEND THE TIMING FOR REMOVAL OF RECEPTACLES AND CONRTAINERS AFTER SOLID WASTE COLLECTION IN CITY OF ROCKWOOD

<u>Section 1.</u> The City of Rockwood ordains that Chapter 212-11 Placement, collection and removal of solid waste and recycling containers, of the Rockwood City Code is hereby amended to provide as follows:

"§ 212-11 Placement, collection and removal of solid waste and recycling containers.

Receptacles, solid waste and recycling containers shall be placed in one or more containers described in §212-9, and shall be placed at the curbside in front of the premises. Receptacles, solid waste and recycling containers shall be placed at that location prior to 7:00 a.m. on the day scheduled for collection from the premises, but in no case shall any receptacles, solid waste and recycling containers be placed at the curbside prior to 6:00 p.m. on the day preceding the scheduled collection day. Such receptacles, solid waste and recycling containers shall be placed in such a way as not to obstruct vehicles, and such receptacles, solid waste and recycling containers shall be readily accessible for collection. All empty receptacles or containers so placed shall be removed from the curbside by 6:00 a.m. the subsequent day of trash collection. The collection day for recyclable material may be separate from the day scheduled for the collection of solid waste, garbage and/or rubbish as set by the City or its authorized representative. Recyclable containers shall be placed and removed during the same time frame as set for solid waste containers. All brush and tree cuttings shall be placed at the street curb and collected by the City at such time as designated by the City."

Section 2. Saving Clause. Nothing in this Ordinance or in the Code hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

<u>Section 3</u>. Severability. Should any word, sentence, phrase or any portion of this Ordinance be held in a manner invalid by any court of competent jurisdiction or by any state agency having authority to do so for any reason whatsoever, such holdings shall be construed and limited to such work, sentence, phrase or any portion of the Ordinance held to be so invalid shall not be construed as affecting the validity of any of the remaining words, sentences, phrases or portions of this Ordinance.

<u>Section 4.</u> Conflicting Ordinances. All prior existing ordinances adopted by the City of Rockwood inconsistent or in conflict with the provisions of this Ordinance are, to the extent of such conflict or inconsistency, hereby expressly repealed.

<u>Section 5</u>. Time. That this Ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect immediately from and after the date of its final passage and adoption.

Section 6. Codification; Scrivener's Errors:

- (a). Sections 1 and 2 of this Ordinance shall be codified, and all other sections shall not be codified.
- (b). The sections, divisions and provisions of this Ordinance may be renumbered or re-lettered as deemed appropriate by the Code codifier.
- (c). Typographical errors and other matters of a similar nature that do not affect the intent of this Ordinance, as determined by the City Clerk and City Attorney, may be corrected with the endorsement of the City Administrator, or designee, without the need for a public hearing.

<u>Section 7.</u> **Publication**. The Clerk for the City of Rockwood shall cause this ordinance to be published in the manner required by law.

This ordinance has been approved by the City of Rockwood City Council in a regular meeting held on September 18, 2024, at City Hall at a properly noticed meeting.
